3. Protective gear is compulsory at every lesson. Any equipment utilized must be approved and/or provided by Mondezie Kickboxing Training Centre. Gear includes boxing gloves, a skipping rope, hand wraps, and a mouth guard.
4. Location, dates and times are subject to change without prior notice. Please contact Mondezie Kickboxing Training Centre to confirm.
5. Fees, locations, and dates are subject to change without prior notice. Please contact Mondezie Kickboxing Training Center to confirm.
6. All prices include GST & QST.
7. An administrative fee of \$20.00 will be charged for all returned cheques.
8. By virtue of section 195 (b) of the *Consumer Protection Act* (R.S.Q., chapter P-40.1), cancellation of the contract will result in a penalty fee of the lesser of \$50, or 10% of the services that were not rendered.
